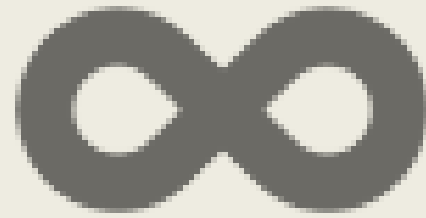

## **Eligibility criteria for Car lease**

The eligibility criteria you will have to fulfil in order to lease Car is given below:

The minimum age of eligibility is 21 years while the maximum age of eligibility is 50 years.

You must hold a valid driving license and should be able to furnish documents such as your Aadhaar Card, Passport, etc. as your address proof.

Salaried individuals whose monthly income is above Rs.40,000/- can get a car on lease. For self-employed individuals they should have their monthly income above Rs.60,000/- in order to be eligible for a car lease from ZED CAR RENTAL & LEASE CO.

The ongoing EMIs should be less than the 50% of the income.



## Documents required

The documents you will have to submit in order to be eligible for a car lease from ZED CAR RENTAL & LEASE CO. are given below:

You will be required to submit your

- PAN Card,
- address proof such as your Aadhaar Card, Passport, etc., and your driving license for KYC purposes.
- Proof of income.
- Bank statements.
- ITR 2 Years
- Photograph of the applicant.

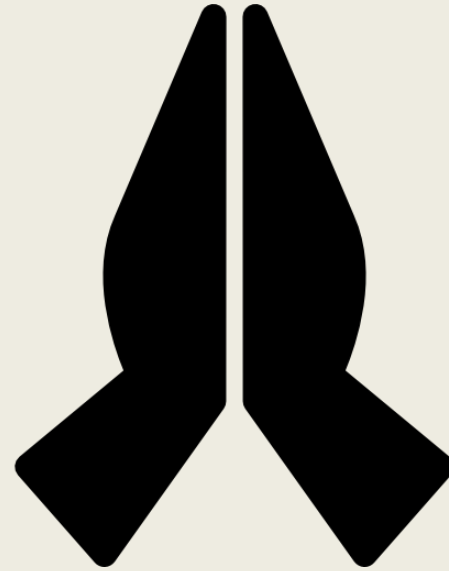
